

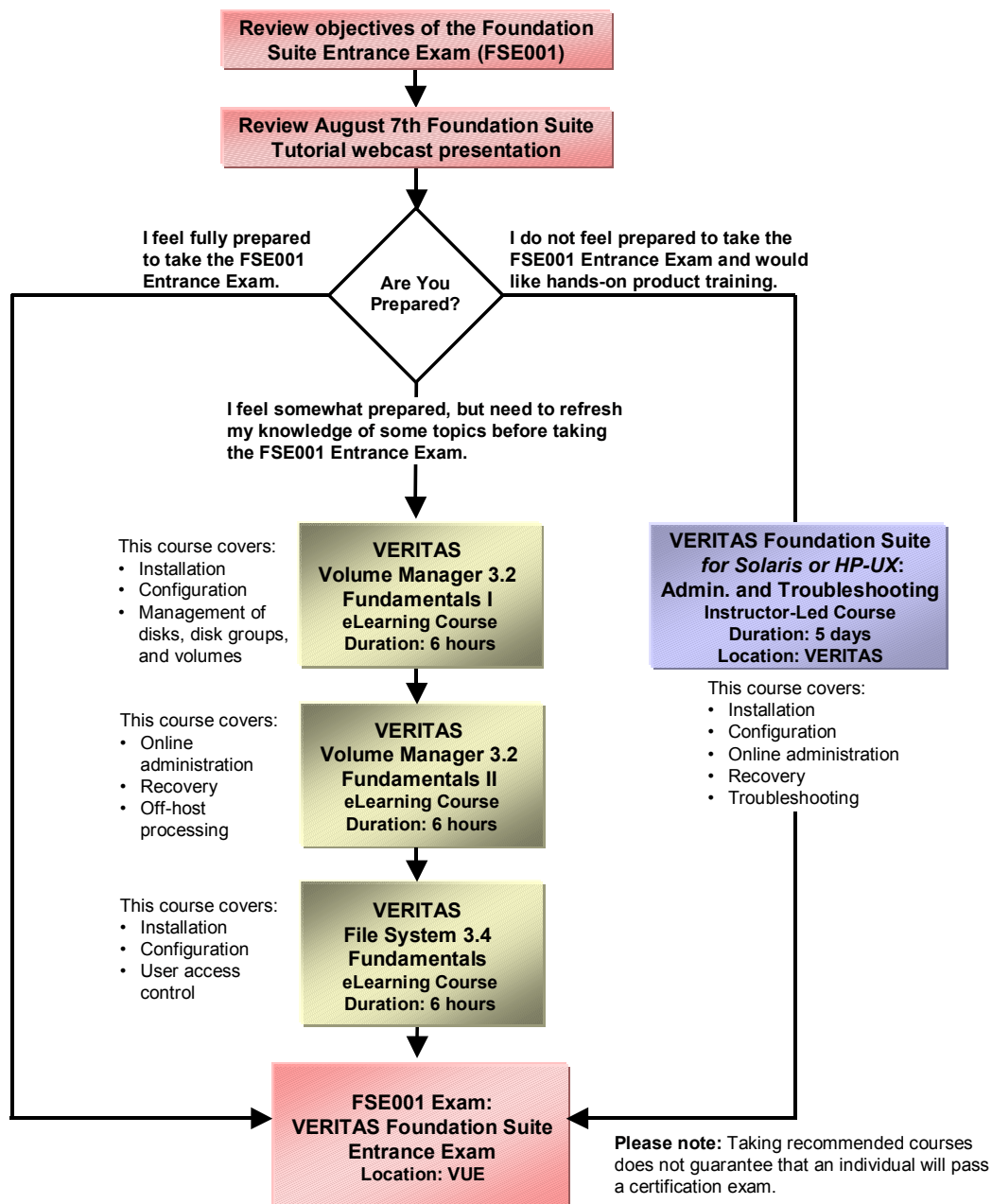

Achieving Level 1 Certification

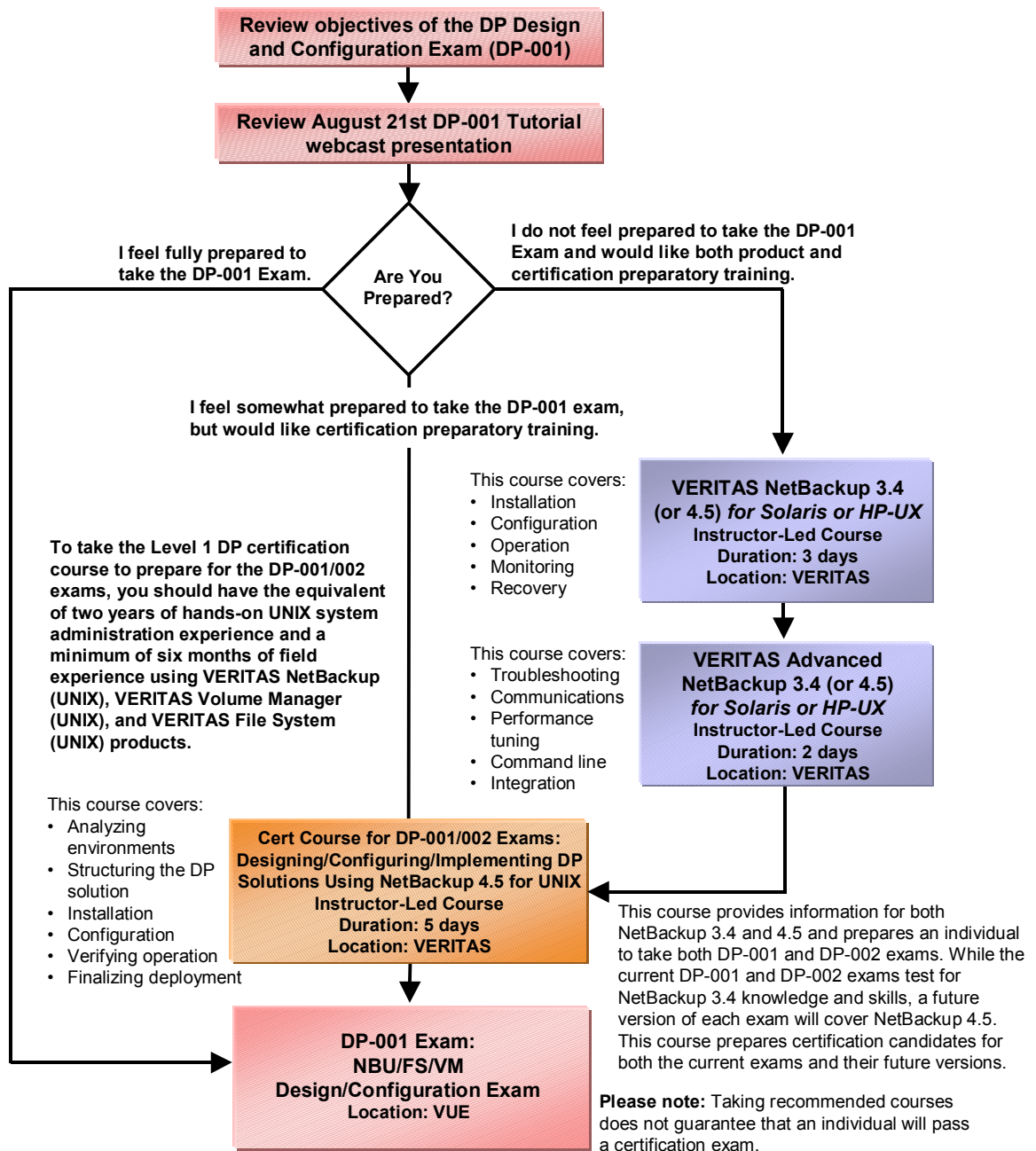
Step 1: Pass the Foundation Suite Entrance Exam (FSE001).

Before entering the Data Protection Track, you must pass the Foundation Suite Entrance Exam (FSE001), which is a prerequisite to achieving Level 1 certification. Evaluate your current knowledge of VERITAS Foundation Suite and determine what level of preparation you need to pass the FSE001 Entrance Exam. To help assess your level of preparation for the exam, review the FSE001 Entrance Exam objectives (at www.veritas.com/PartnerNetwork or www.vue.com/veritas). It is also recommended that you listen to the archived presentation of the August 7th, 2002 Foundation Suite Tutorial webcast (at www.placewareforum.com/veritas/ click Partners/click Archive), if you did not attend the live webcast. The webcast presentation without audio is also available for download at www.veritas.com/PartnerNetwork. You should have product knowledge of VERITAS Volume Manager 3.2 (UNIX) and VERITAS File System 3.4 (UNIX), in addition to general knowledge of storage concepts and terminology and practical experience with these products.



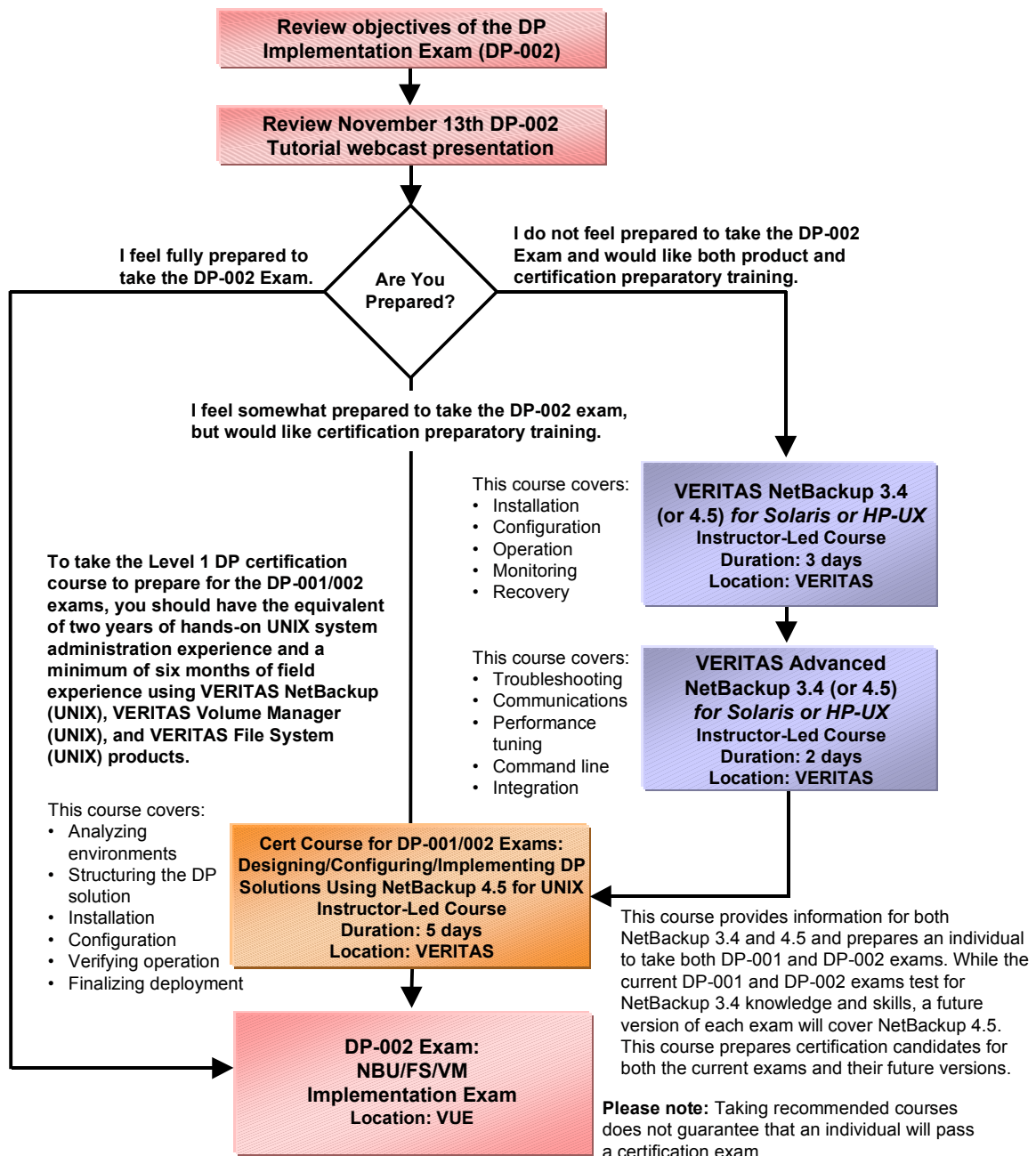
Step 2: Enter the Data Protection Track, and pass the Design and Configuration Exam (DP-001).

To achieve Level 1 certification, you must pass the NBU/FS/VM Design and Configuration Exam (DP-001). Evaluate your current level of knowledge and job experience in the design and configuration of data protection solutions using VERITAS NetBackup 3.4 (or 4.5) for Solaris or HP-UX to determine the level of preparation you need to pass the exam. To help assess your level of preparation for the exam, review the DP-001 Exam objectives (at www.veritas.com/PartnerNetwork or www.vue.com/veritas). It is also recommended that you listen to the archived presentation of the August 21st, 2002 Data Protection Design/Configuration Exam (DP-001) Tutorial webcast (at www.placewareforum.com/veritas/ click Partners/click Archive), if you did not attend the live webcast. The webcast presentation without audio is also available for download at www.veritas.com/PartnerNetwork. You should have product knowledge of VERITAS NetBackup 3.4 (or 4.5) (UNIX), VERITAS Volume Manager 3.2 (UNIX) and VERITAS File System 3.4 (UNIX), in addition to general knowledge of backup and storage concepts and terminology, storage hardware, infrastructure performance considerations, and practical experience with these products.



Step 3: Pass the Implementation Exam (DP-002).

To achieve Level 1 certification, your next step is to pass the NBU/FS/VM Implementation Exam (DP-002), which will be available for general availability in November 2002. Evaluate your current level of knowledge and job experience in the implementation of data protection solutions using VERITAS NetBackup 3.4 (or 4.5) for Solaris or HP-UX to determine the level of preparation you need to pass the exam. To help assess your level of preparation for the exam, review the DP-002 Exam objectives (at www.veritas.com/PartnerNetwork or www.vue.com/veritas). It is also recommended that you listen to the archived presentation of the November 13th, 2002 Data Protection Implementation Exam (DP-002) Tutorial webcast (at www.placewareforum.com/veritas/clickPartners/clickArchive), if you did not attend the live webcast.
